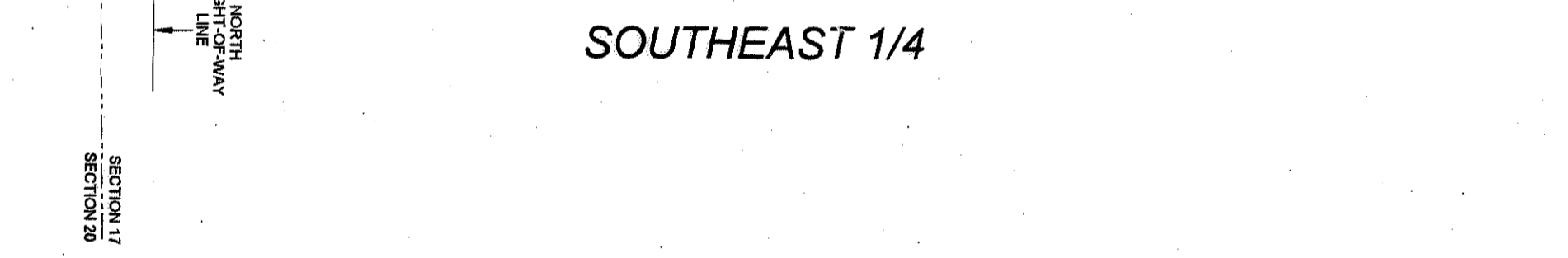
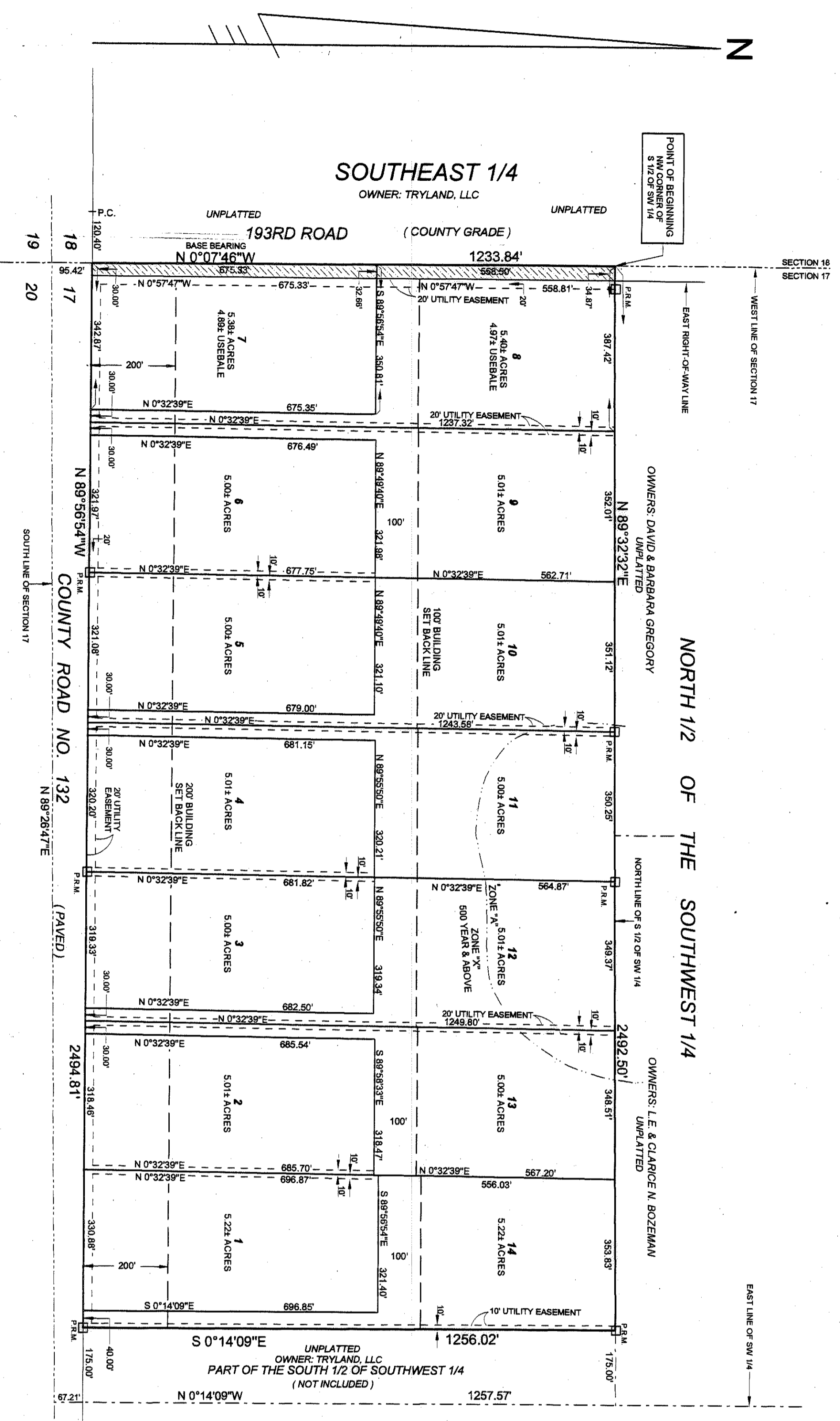


Turning Leaf

PART OF THE SOUTH 1/2 OF THE SOUTHWEST 1/4 OF SECTION 17, TOWNSHIP 1 SOUTH, RANGE 12 EAST, SUWANNEE COUNTY, FLORIDA, BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS: FOR POINT OF BEGINNING, CORNER OF THE NORTHWEST CORNER OF SAID SOUTH 1/2 OF THE SOUTHWEST 1/4, THENCE RUN NORTH 89°32'32" EAST ALONG THE NORTH LINE OF SAID SOUTH 1/2 OF THE SOUTHWEST 1/4, A DISTANCE OF 2492.50 FEET; THENCE RUN SOUTH 00°14'09" EAST, A DISTANCE OF 1256.02 FEET TO THE NORTH RIGHT-OF-WAY LINE OF COUNTY ROAD NO. 132; THENCE RUN NORTH 89°36'54" WEST ALONG SAID NORTH RIGHT-OF-WAY LINE, A DISTANCE OF 2494.81 FEET TO THE WEST LINE OF SECTION 17; THENCE RUN NORTH 00°07'46" WEST ALONG SAID WEST LINE, A DISTANCE OF 1233.84 FEET CONTAINING 71.27 ACRES MORE OR LESS.
