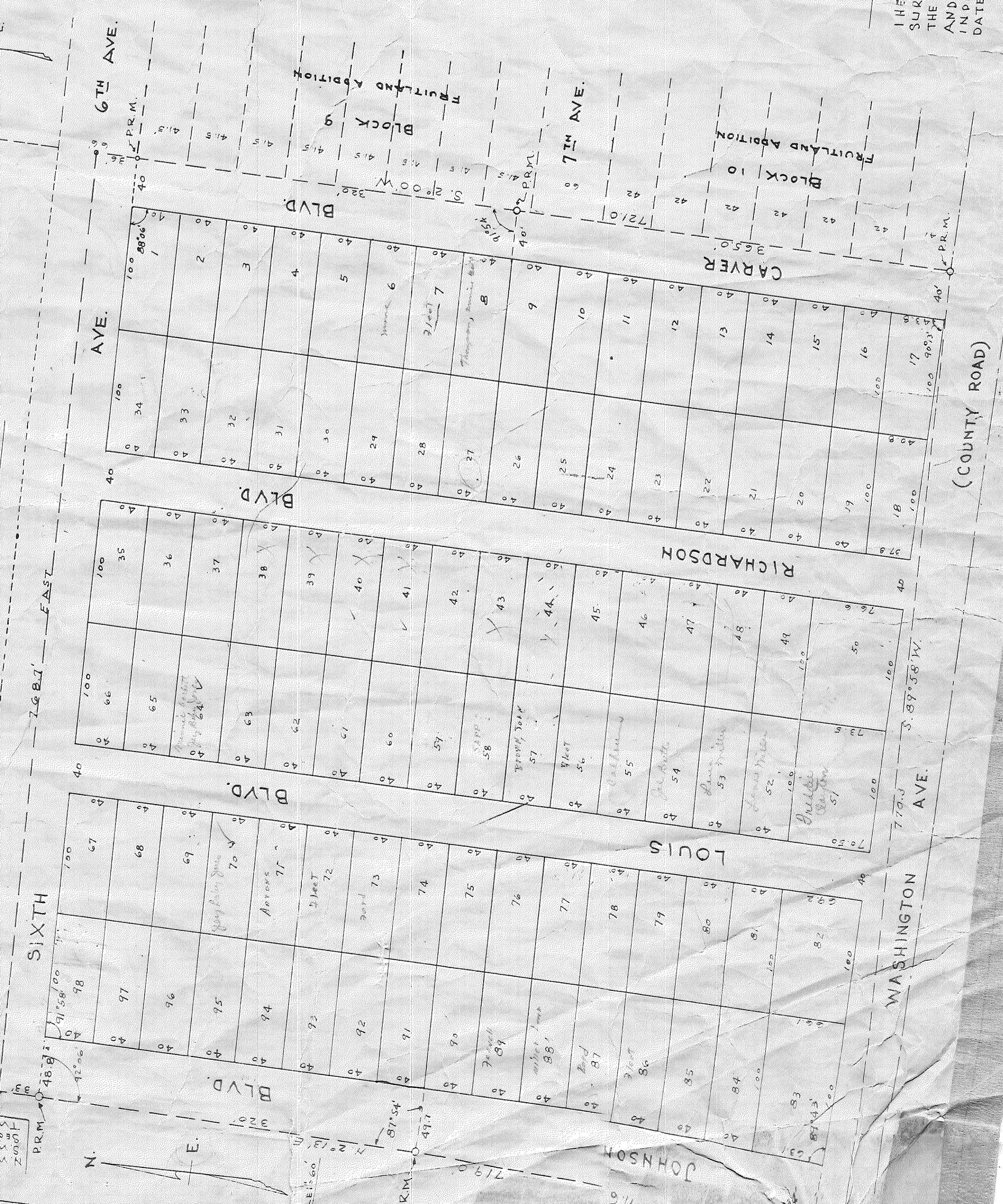

 COMMENCE AT THE NORTHWEST CORNER OF THE SW 1/4 OF THE NE 1/4 OF SECTION 22, TOWNSHIP 2-SOUTH, RANGE 13-EAST, SUWANNEE COUNTY, FLORIDA AND RUN S. 2° 13' W. 605 FEET FOR A POINT OF BEGINNING AND RUN THENCE EAST 168.7 FEET, THENCE S. 2° 00' W. 721 FEET, THENCE EAST 168.7 FEET, 770.3 FEET, THENCE N. 2° 13' E. 713 FEET TO POINT OF BEGINNING.
