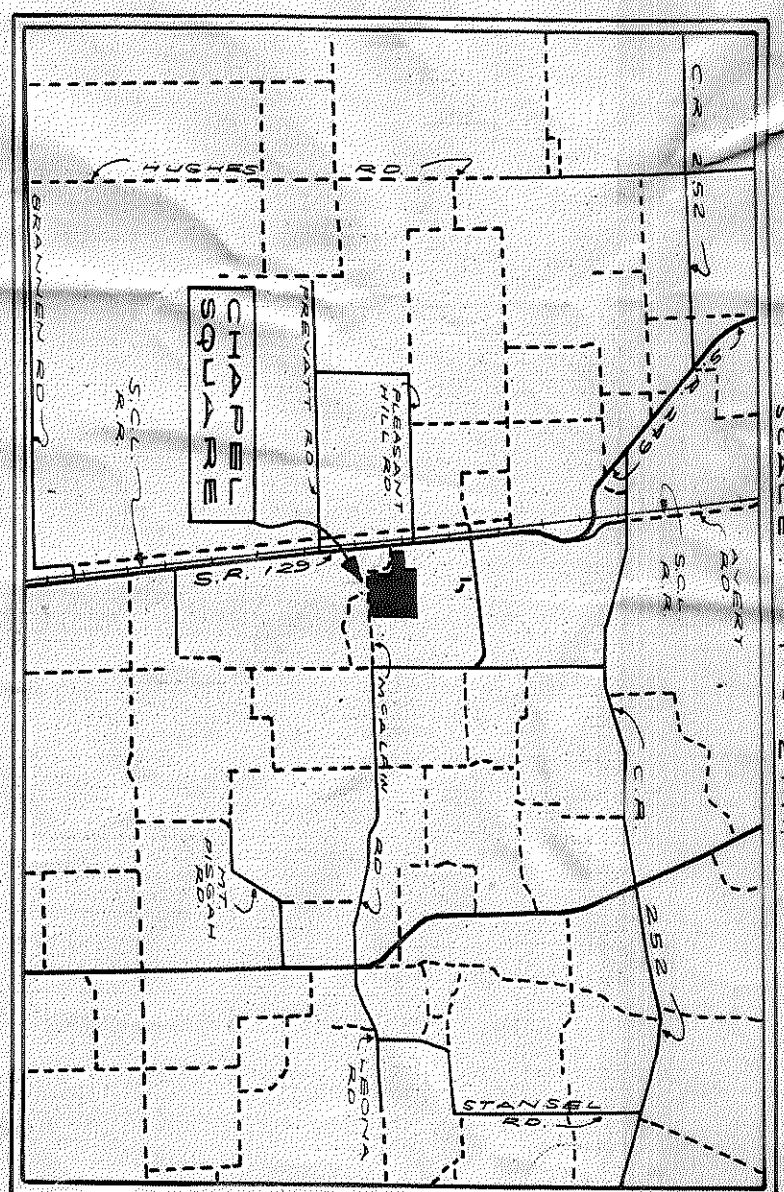


LOCATION MAP

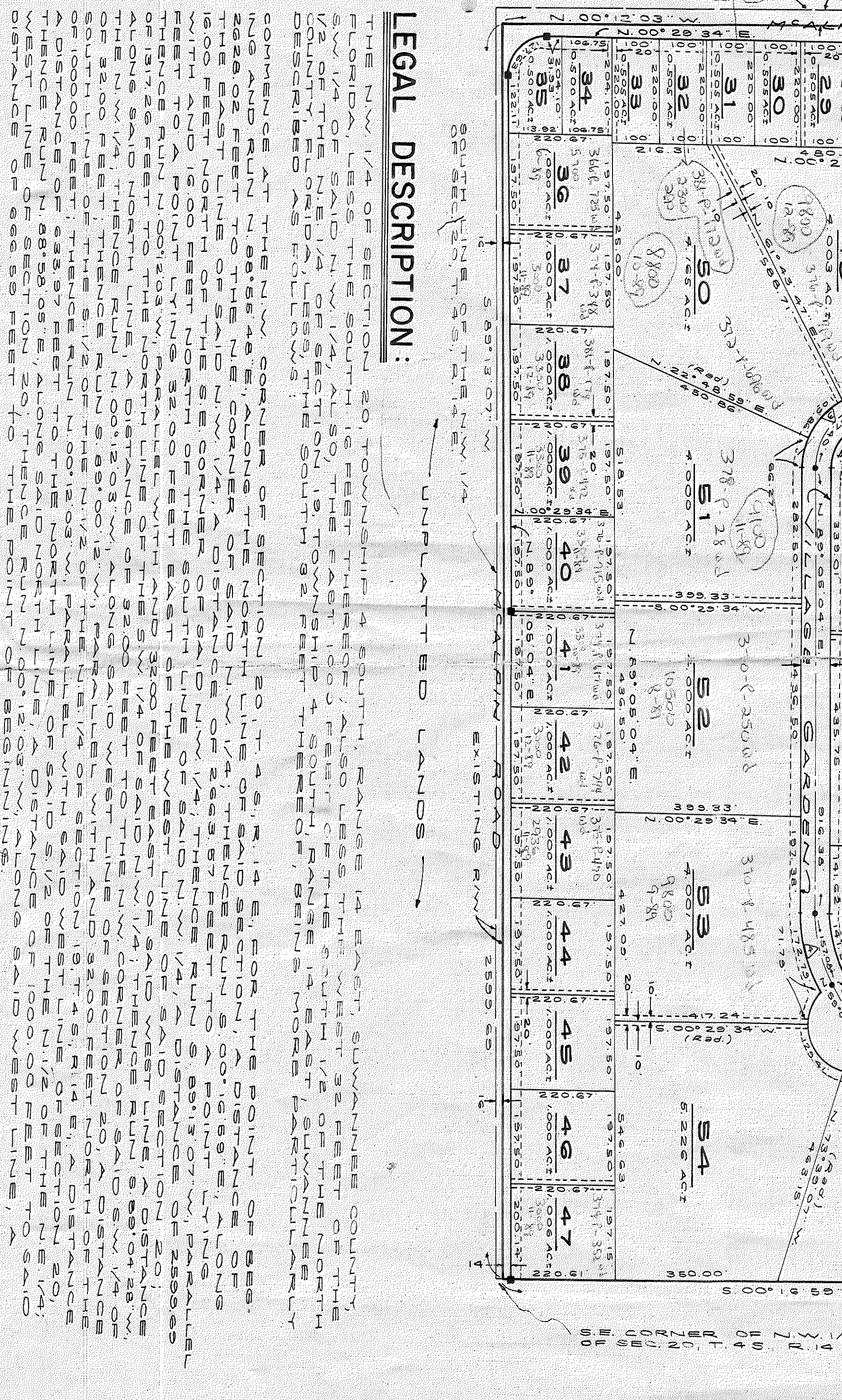
