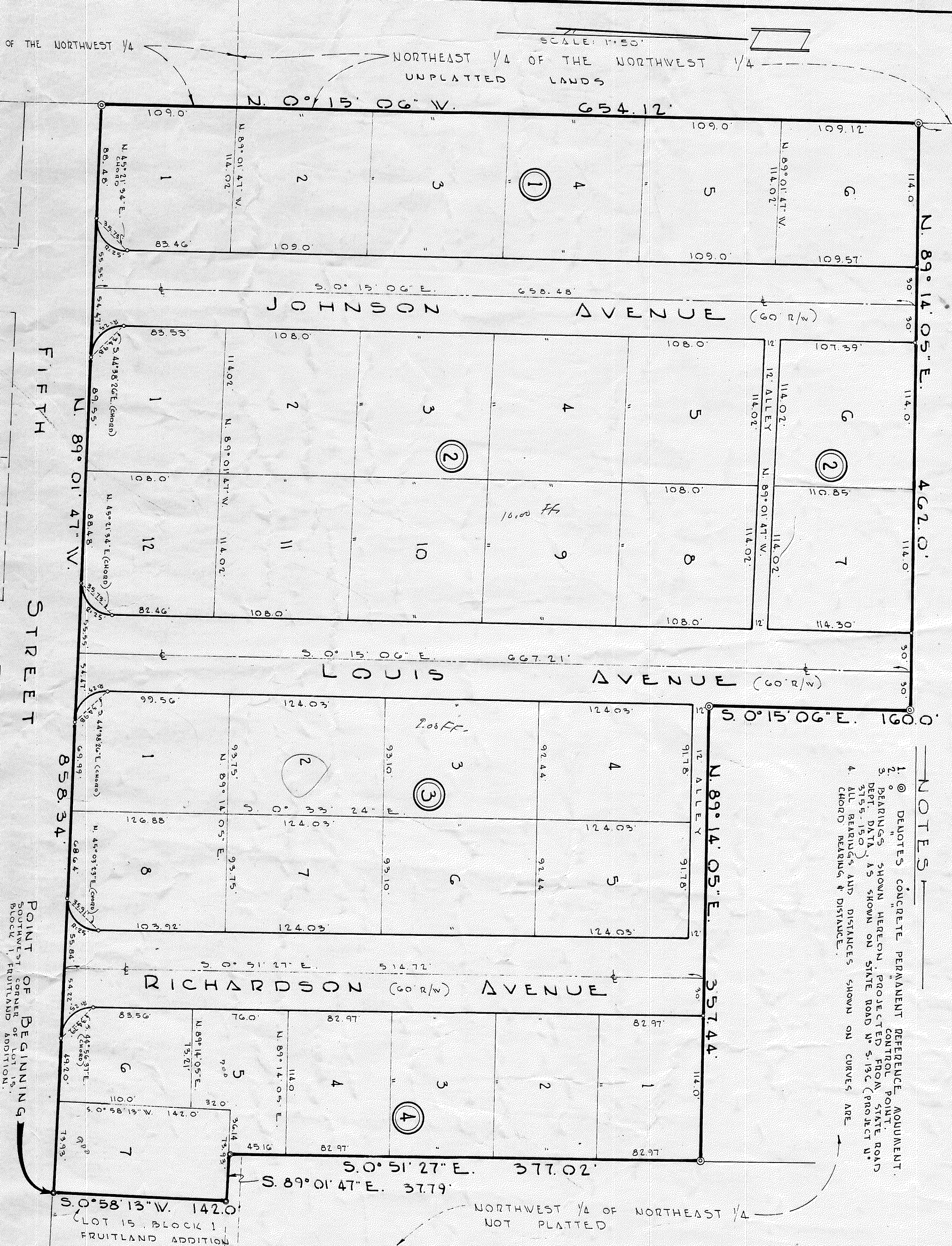
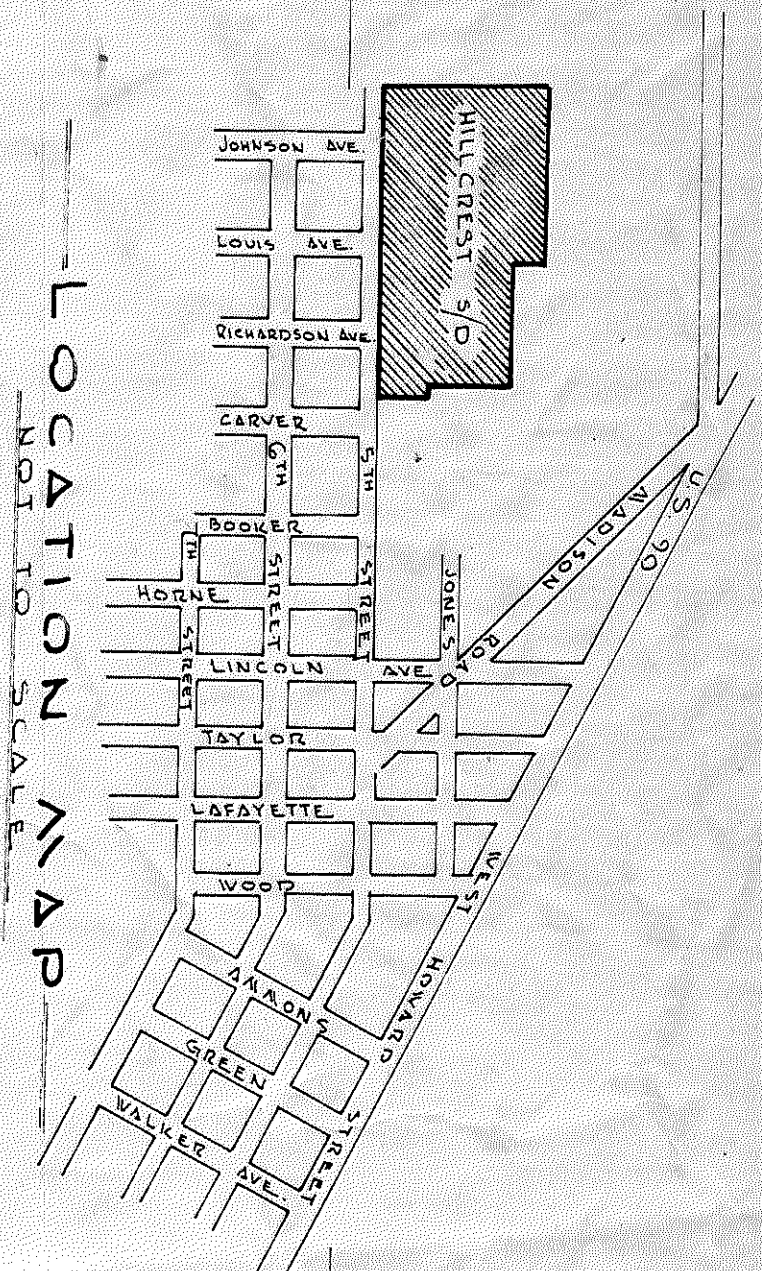


HILLCREST SUBDIVISION

PART OF THE NORTHEAST ONE-QUARTER OF SECTION 22, TOWNSHIP 2 SOUTH, RANGE 13 EAST, SUWANNEE COUNTY, FLORIDA, BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS: FOR POINT OF BEGINNING, COMMENCE AT THE SOUTH WEST CORNER OF LOT 15, BLOCK 1, FRUITLAND ADDITION, AS SHOWN ON PAGE 14 OF THE RECORDS OF SAID COUNTY; THENCE RUN NORTH 89° 01' 47" WEST 858.34 FEET TO THE WEST LINE OF SAID STREET (A 60 FOOT R/W); MEASURE OF 858.34 FEET TO THE WEST LINE OF SAID NORTH 89° 14' 05" EAST 462.0 FEET TO THE NORTHWEST CORNER OF SAID ONE-QUARTER OF SAID QUARTER; THENCE RUN NORTH 89° 14' 05" EAST 462.0 FEET TO THE NORTHWEST CORNER OF SAID ONE-QUARTER OF SAID QUARTER; THENCE RUN NORTH 0° 15' 06" EAST 377.92 FEET TO THE NORTHWEST CORNER OF SAID LOT 15, BLOCK 1, FRUITLAND ADDITION; THENCE RUN SOUTH 0° 15' 06" EAST 377.92 FEET TO THE WEST LINE OF SAID STREET; THENCE RUN SOUTH 89° 01' 47" WEST 858.34 FEET ALONG THE WEST LINE OF SAID LOT 15, BLOCK 1, FRUITLAND ADDITION, 11.37 ACRES MORE OR LESS.
