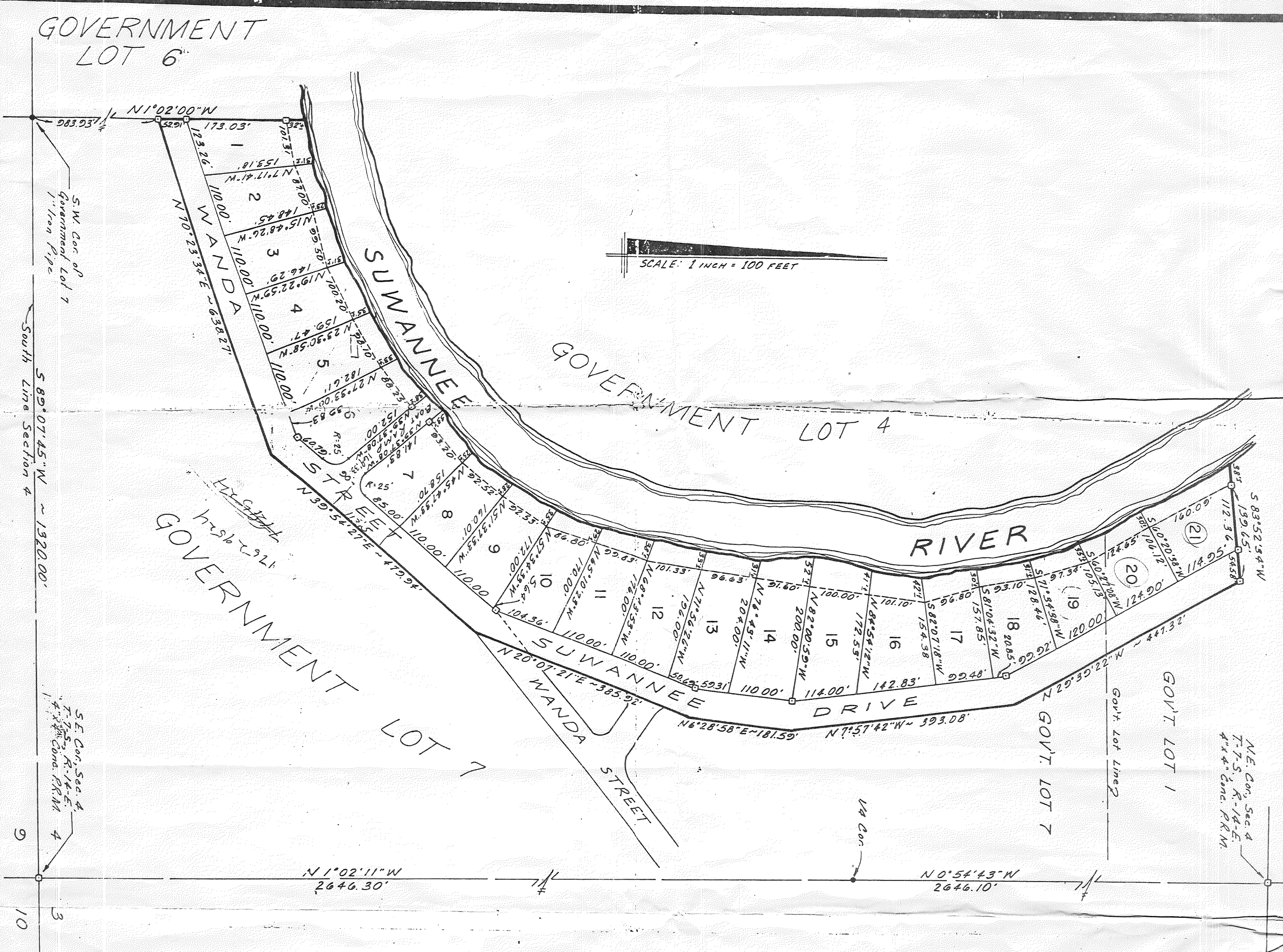


# THE LITTLE HORSESHOE

BEING A PART OF GOV'T. LOTS 1 & 7,  
SECTION 4, TOWNSHIP 7 SOUTH, RANGE 14 EAST  
SUWANNEE COUNTY, FLORIDA



**DESCRIPTION:**

COMMENCE at the Southeast Corner of Section 4, Township 7 South, Range 14 East, Suwannee County, Florida and run S 89° 07' 45" W along the South line of said Section 4 a distance of 1320.00 feet to a 1 inch iron pipe on the SW Corner of a Government Lot 7; thence N 1° 02' 00" W along the West line of said Government Lot 7 a distance of 985.93 feet to the POINT OF BEGINNING; thence N 70° 15' 42" E 638.27 feet; thence N 59° 54' 27" E 479.94 feet; thence N 20° 07' 21" E 985.92 feet; thence N 6° 28' 58" E 11.59 feet; thence N 7° 57' 22" W 593.08 feet; thence N 29° 59' 22" W 447.92 feet; thence S 83° 52' 34" W 139.65 feet to a concrete P.R.M. on the East Bank of the Suwannee River; thence continue S 83° 52' 34" W along some line 98 feet more or less to the Water Edge of the Suwannee River; thence Southward and Westerly along and with the meander of the water's edge of the Suwannee River 2100 feet more or less to a point on the West line of a Government Lot 7, said point being N 1° 02' 00" W 258 feet more or less from the POINT OF BEGINNING; thence S 1° 02' 00" W 258 feet more or less along, said West line of Government Lot 7 to a concrete P.R.M. on the Southern Bank of the Suwannee River; thence continue S 1° 02' 00" E along some line 225.94 feet to the POINT OF BEGINNING.
