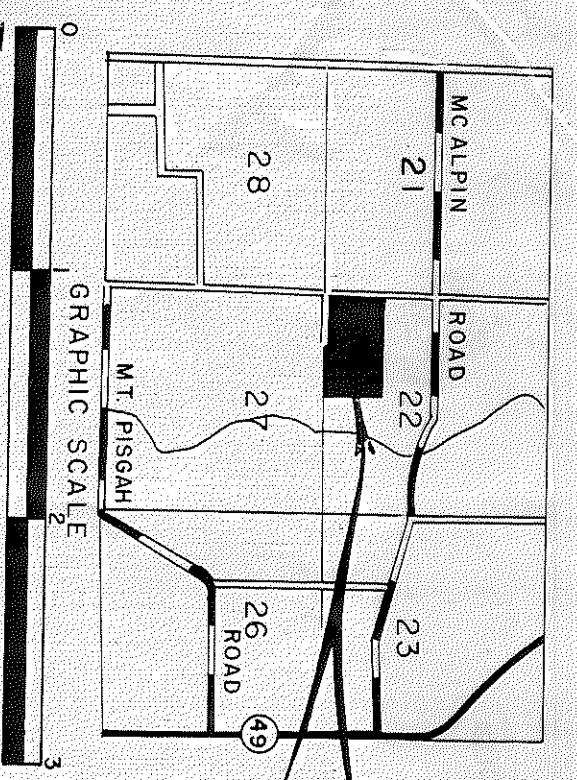


LITTLE RIVER FARMS

SUWANNEE COUNTY, FLORIDA

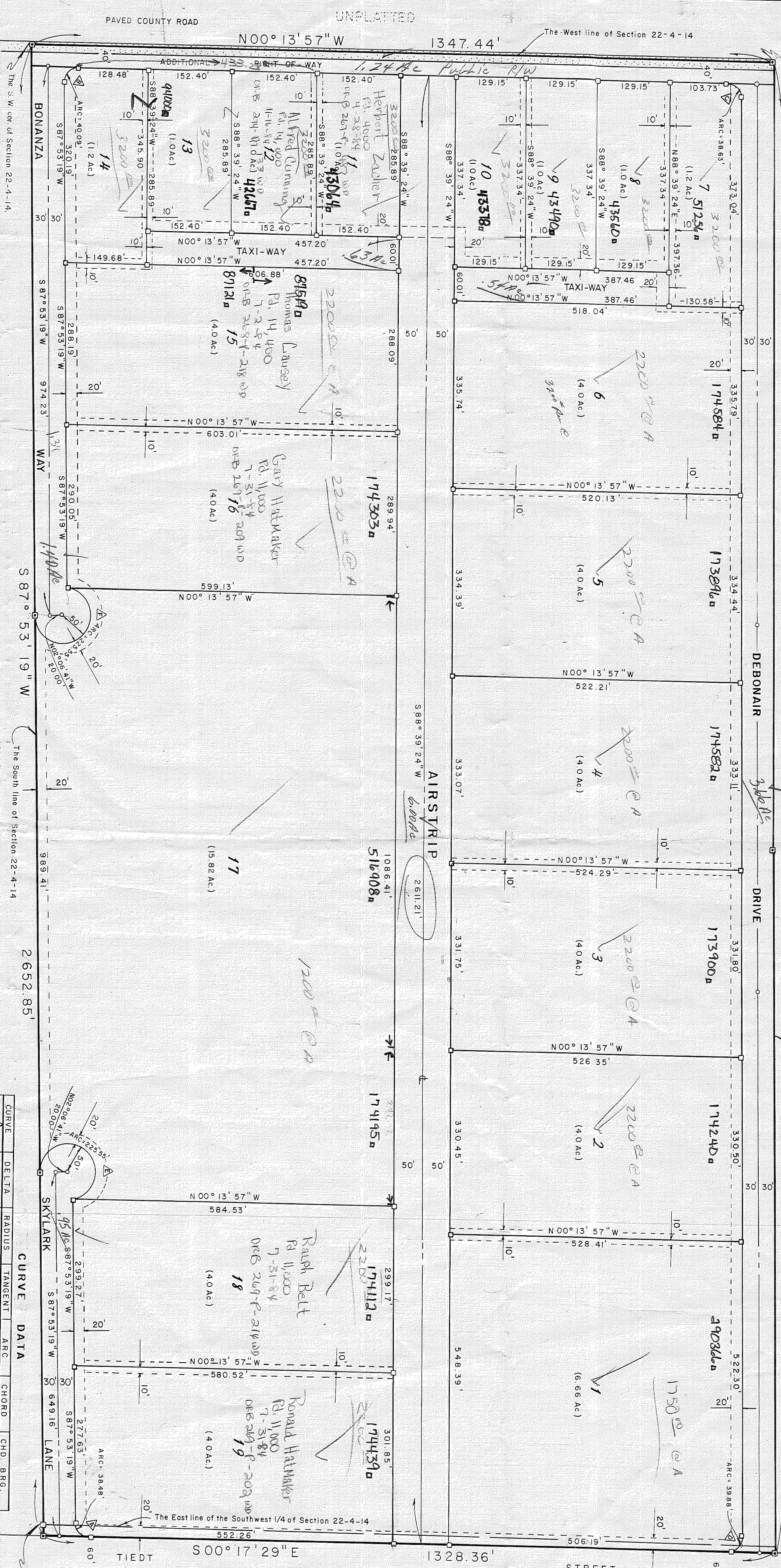

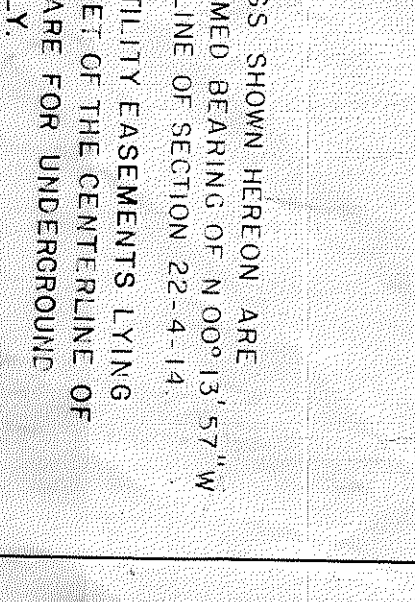
