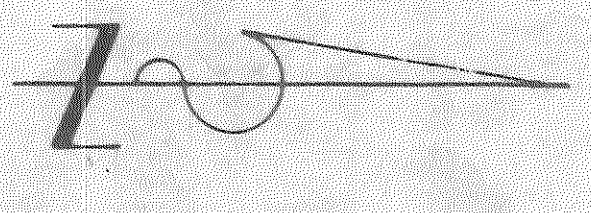


PINE FOREST MANOR
