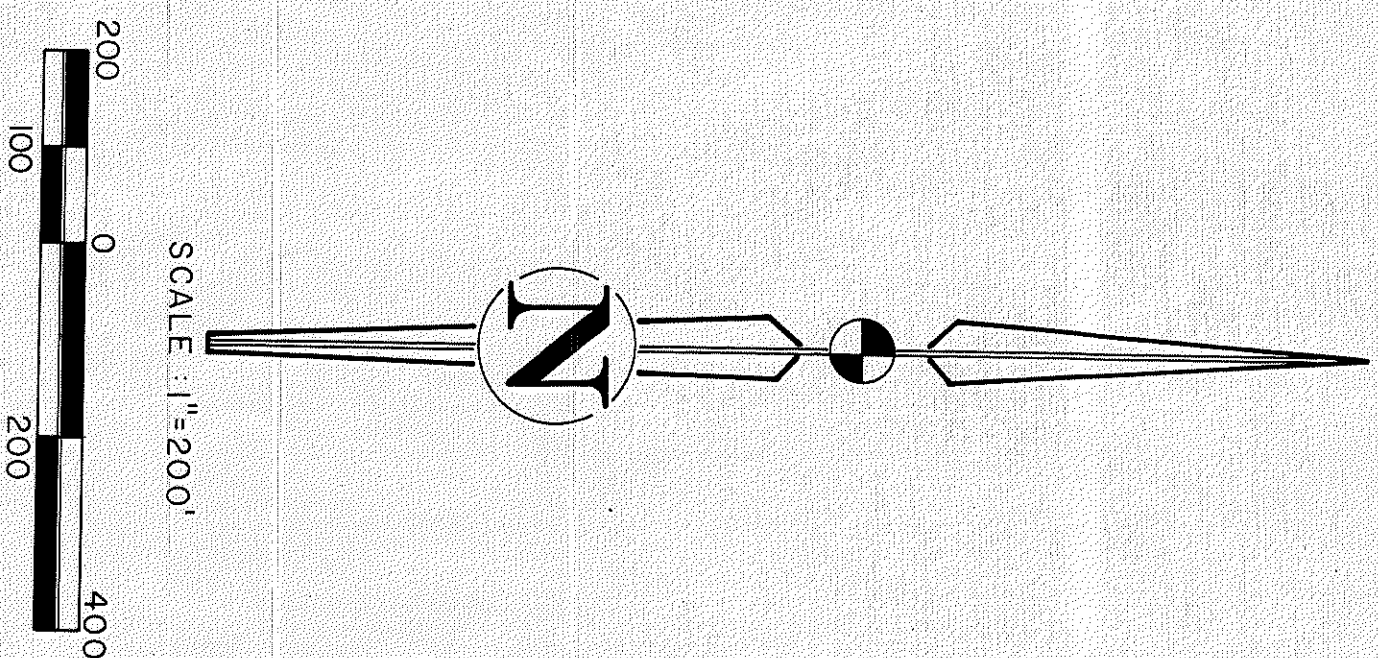

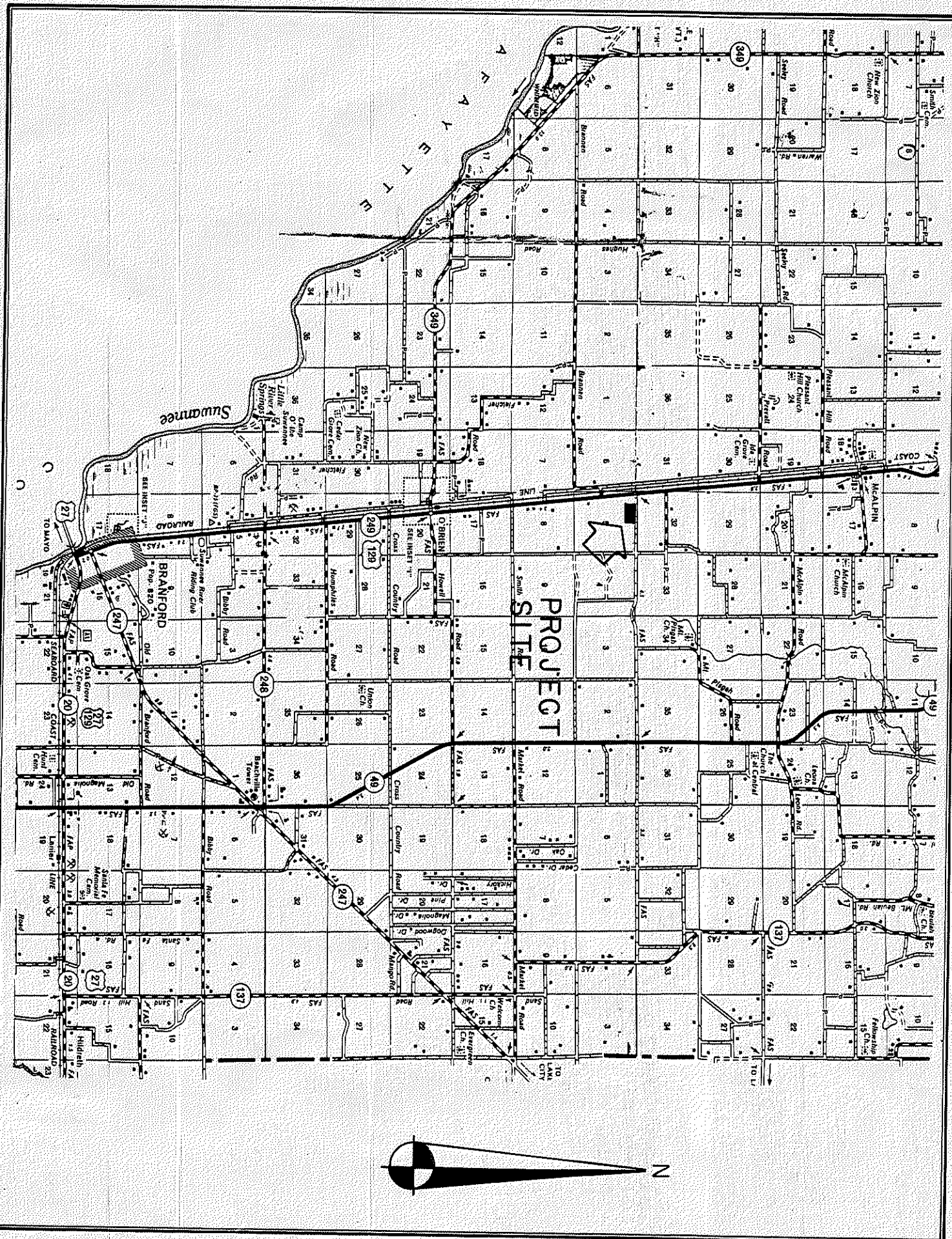

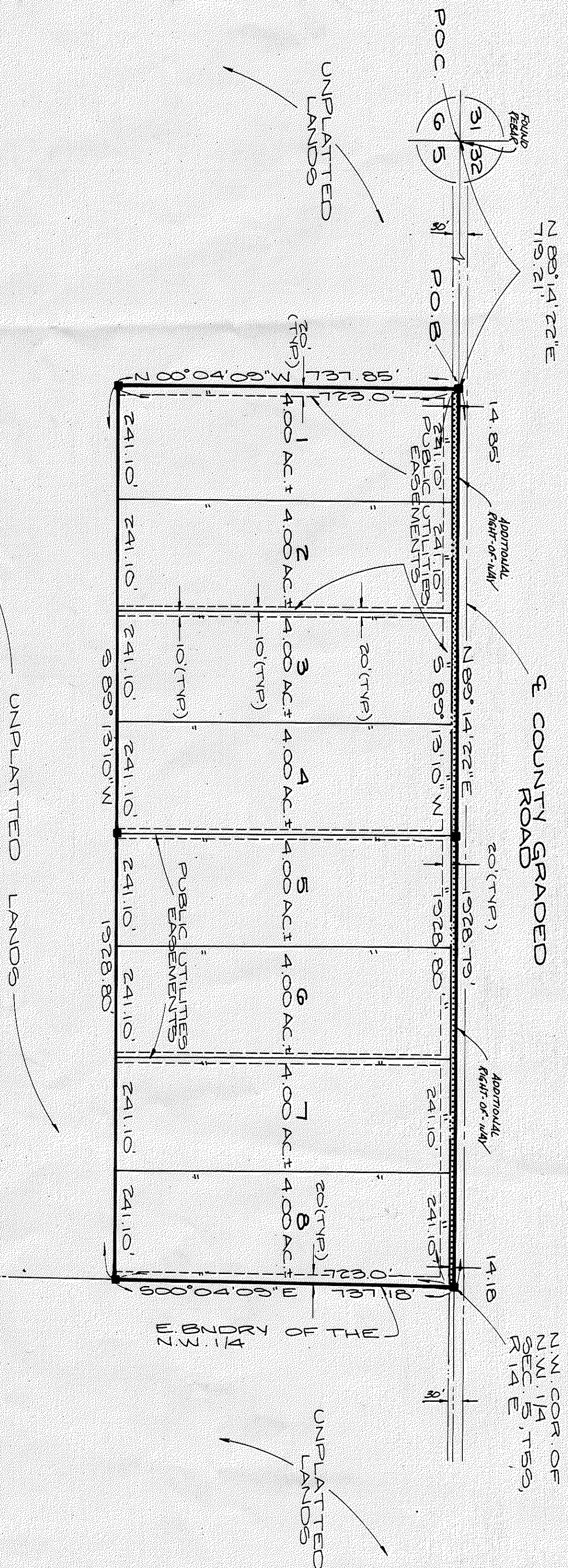
POB - MEANS POINT OF BEGINNING

LEGAL DESCRIPTION

A PORTION OF SECTION 5, TOWNSHIP 5 SOUTH, RANGE 14 EAST, SUWANNEE COUNTY, FLORIDA BEING MORE PARTICULARLY COMMENCED A TOWNSHIP CORNER OF SAID SECTION 5 AND RUN THENCE N 85° 13' 10" W TO THE POINT OF BEGINNING 100.04' 09" FEET TO THE POINT OF BEGINNING (POB) THEN S 89° 04' 09" E ALONG THE NORTH SIDE BOUNDARY OF SAID SECTION 5, 300.04' 09" FEET TO THE POINT OF BEGINNING (POB) THEN N 00° 04' 09" W, 137.85 FEET TO THE POINT OF BEGINNING 32.65 ACRES, MORE OR LESS.
