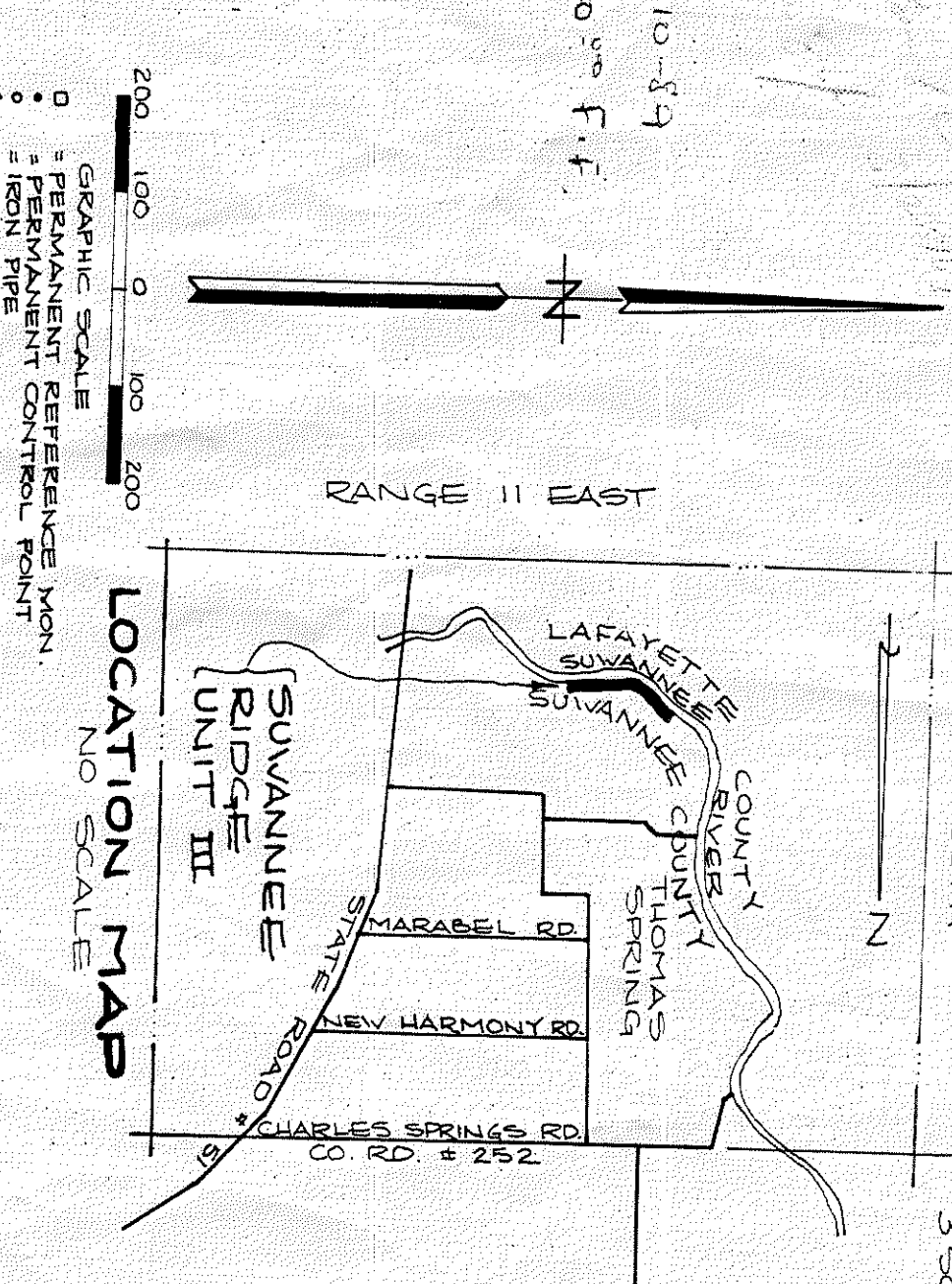
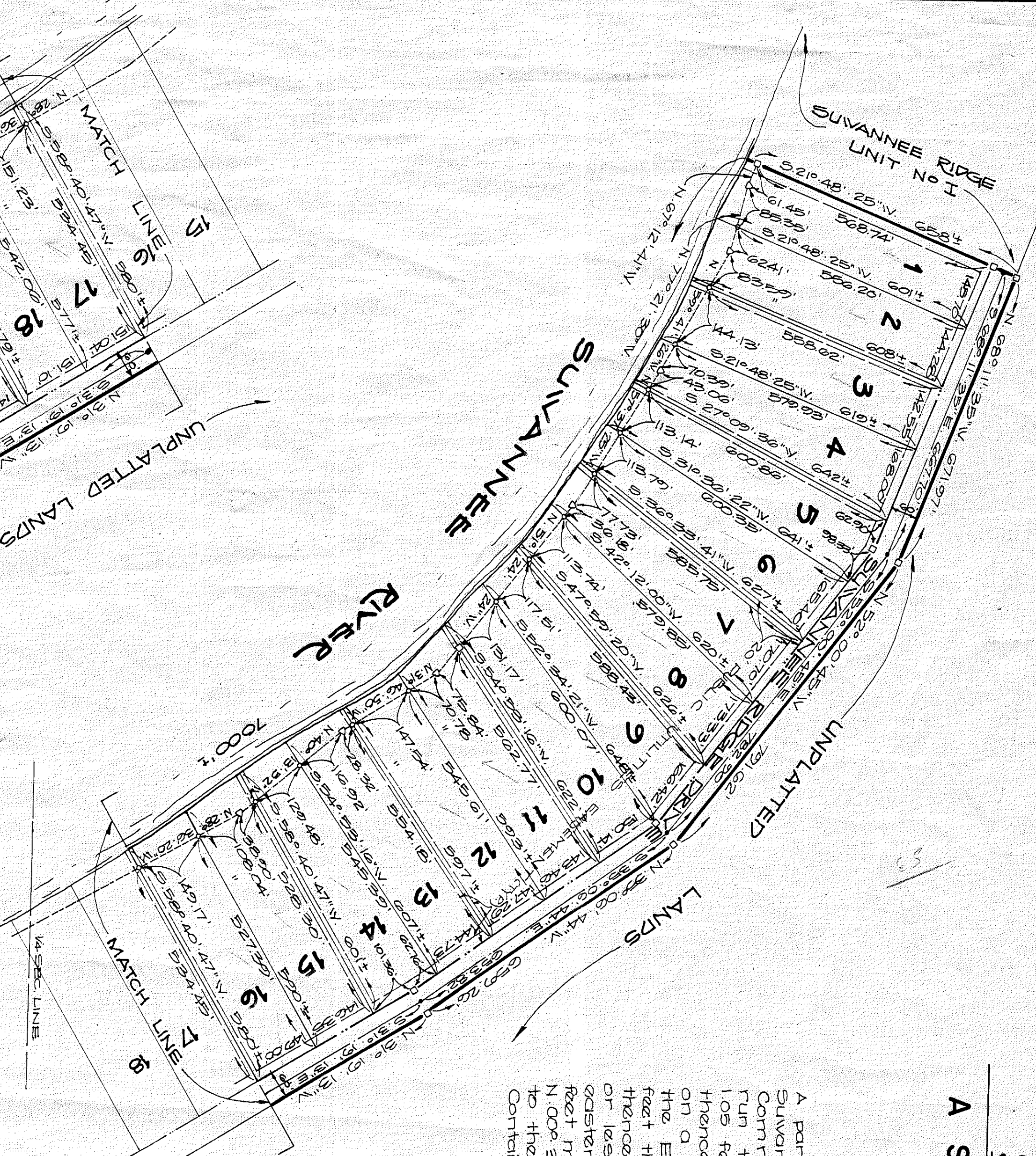


**SUWANNEE RIDGE UNIT III**

**LEGAL DESCRIPTION**

A part of sections 27 and 28 Township 4 South, Range II East, Suwannee County Florida being more particularly described as follows: Commence at the northeast corner of the SW 1/4 of said section 27 and run thence S 00° 34' 48" E, along the east boundary of said SW 1/4, thence S 68° 45' 29" W, 788.52; thence N 95° 16' 41" W, 1463.42 feet; on a line common to the west boundary of said section 27 and the East boundary of said section 28; thence N 31° 19' 12" W, 1997.90; thence N 08° 11' 35" W, 671.97 feet; thence S 21° 46' 25" W, 658.62 feet or less to the water's edge of the Suwannee River thence more easterly, easterly, and northeasterly along said water's edge 7000 feet more or less to the East boundary of said SW 1/4, thence N 00° 34' 48" W, along said East boundary 650 feet more or less to the P.O.B.
