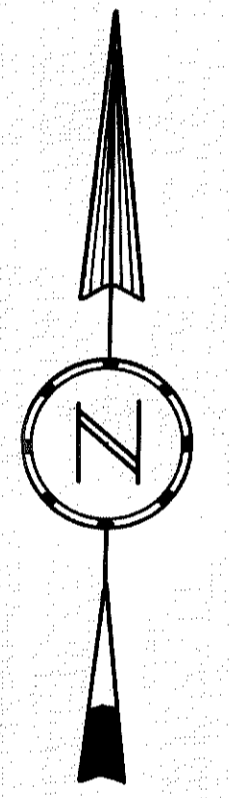
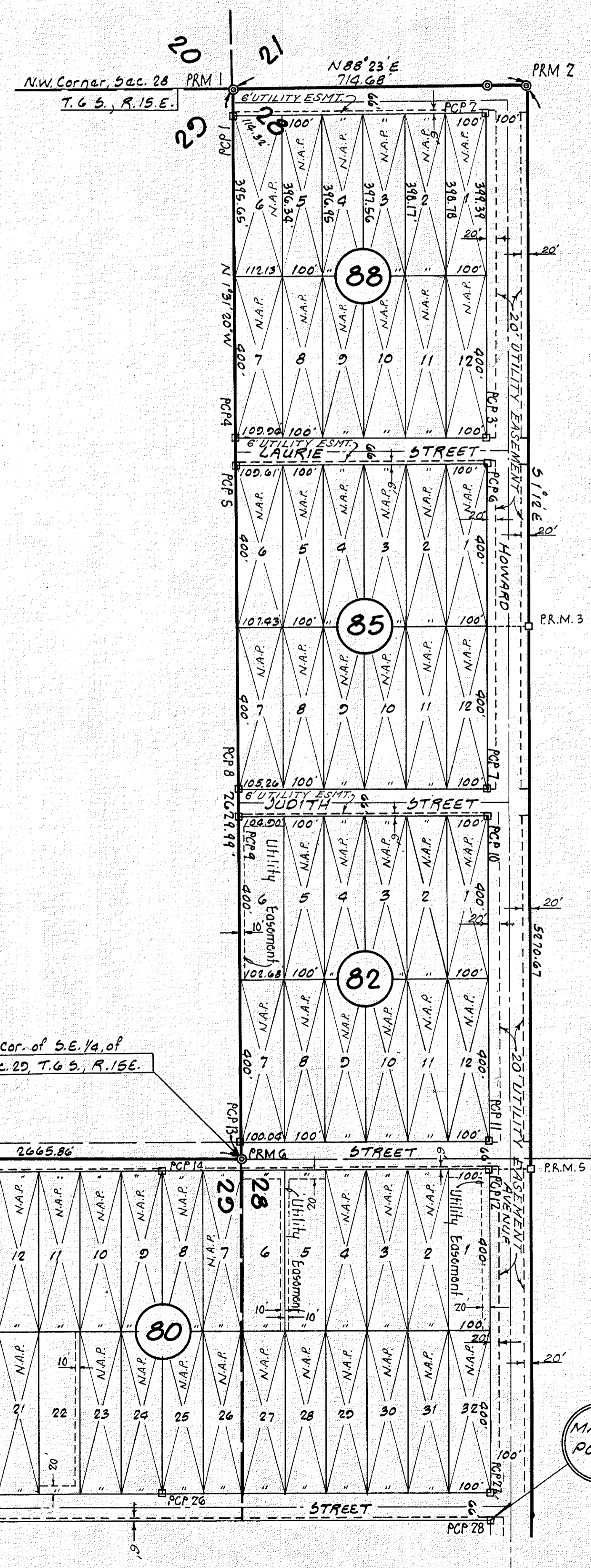


THREE RIVERS ESTATES UNIT NO. 2

DESCRIPTION:

Begin at the Northwest Corner of Section 28, Township 6 South; Range 15 East, Suwannee County, Florida and run N88°23'E along North Line said Section 28 719.68 feet; thence S1°12'E 5270.67 feet to a point on South Line said Section 28; thence S1°12'E 1112.83 feet to a point on North Line River Road; thence S45°28'W 290.61 feet along said North Line River Road; thence S25°28'W 402.41 feet along said North Line River Road; thence S88°48'W 3007.19 feet to West Line Northeast 1/4 of Section 32; thence N1°26'W 1654.98 feet to Northwest Corner said Northeast 1/4 Section 32; thence N1°25'40'W 2649.30 feet to Northwest Corner Southeast 1/4 Section 29; thence N85°07'25"E 2665.86 feet to Northeast Corner said Southeast 1/4 Section 29; thence N1°31'20'W 2629.99 feet to Point of Beginning.
