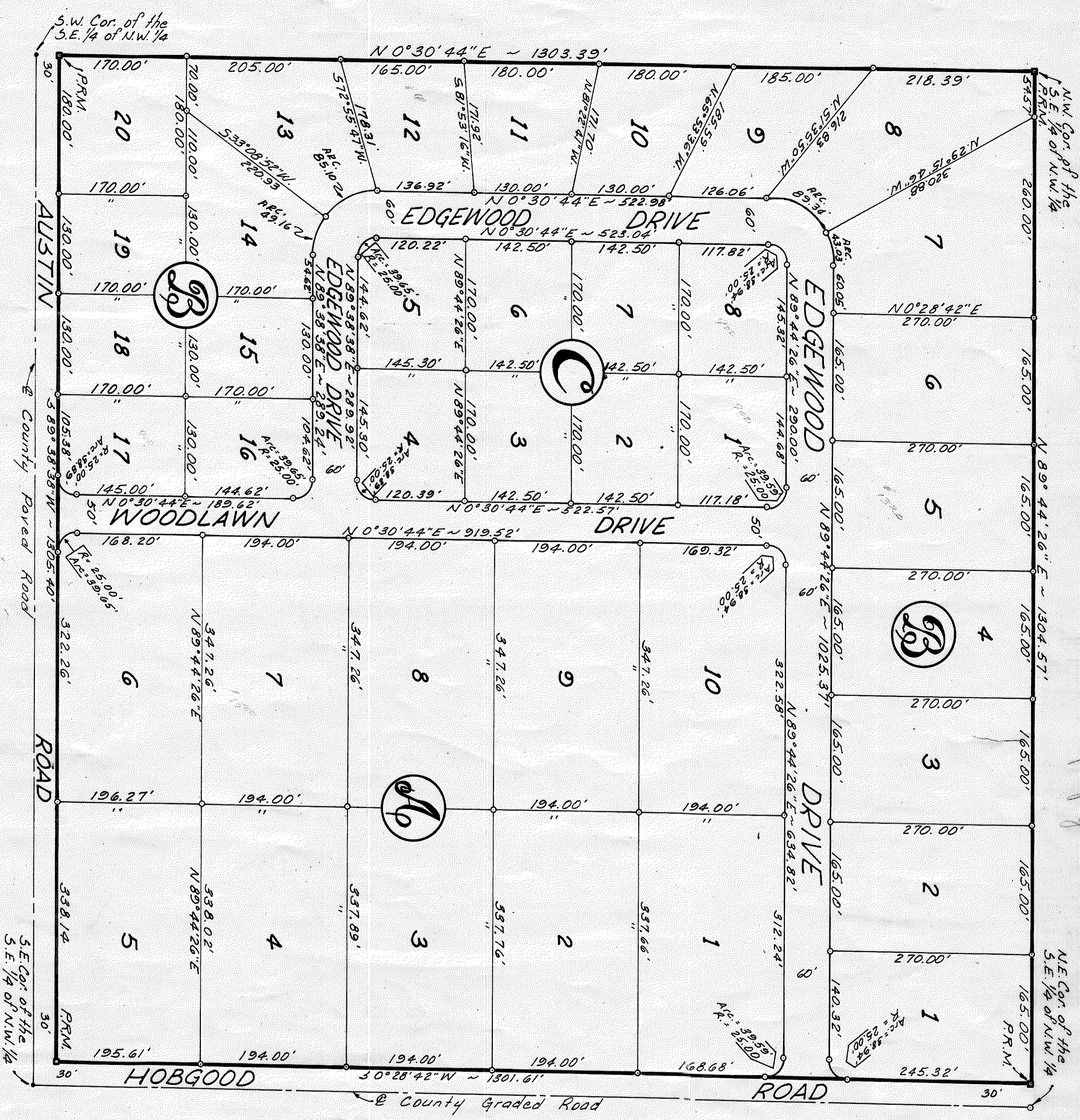


# WESTWOOD ESTATES
